Release and waiver of Liability and indemnity Agreement (Read Carefully before signing)

In consideration of being permitted to participate in any way in the Material Arts Program, including, but not limited to any classes, Treatments or other groups or Individual activities and/or being permitted to enter for any purpose any restricted area, the participant (or in the event the participant is a minor their parents or legal Guardians) Name Agree:

1. Participants acknowledge that they fully understand that:
 - A). There are risks and dangers associated with participation in martial arts events and activities which could result in bodily injury partial and/or Total disability, paralysis or death.
 - B). The social and economic losses and/or damages, which could result from these risks and danger described above, could be severe.
 - C). these risks and dangers may be caused by the action, Inaction or negligence of the participants or other, including, but not limited to, the Releases names below.
 - D). There may be other risks not known to us or are not reasonably foreseeable at this time.
2. Prior to participating in the below martial arts activity or event, participants(or their parents or legal Guardian) understand they should inspect the Facilities and equipment to be used, and if the participants believes anything is unsafe, the participants should immediately advise the officials of such Condition and refuse to participate. Participants acknowledge that he/she understands and will immediately REFUSE TO PARTICPATE further if they feel anything to be unsafe.
3. Participants (or if a minor, parents or legal Guardian of the minor) accepts the risks and responsibility for the losses and/or damages following any injury, disability, paralysis or death, However caused and whether caused in whole or in part by the negligence of the releases names below.
4. Participants (or parent or legal guardian of a minor participants) hereby WAIVES, DISCHARGES AND PROMISES NOT TO SUE the martial arts facility used by the participants, including its owners, managers, promoters, lessees of premises used to conduct the martial arts event or program, premises and events inspectors, underwrites, consultants and others who give recommendation, directions or instructions to engage in risk evaluation or loss control activities regarding the martial arts facility or events held at such facility and each of them, their directors, officers, agents, employees, all for the purpose herein referred to as 'Release', from any liability to the undersigned participants, or their personal representatives, assigns, executors, heirs and next of kin for any and all claims, demands, losses or damages and any claims or demands therefore on accounts of any injury, including but not limited to the death of the participants or damage to property, arising out of or relating to the events(s) caused , allege to be caused, in whole or in part by the negligence of the Releases. In the event the participants or minor file suit despite signing this release, the participants, or in the case of minors, the parent or legal Guardian of the minor, agree to defend, hold harmless, and indemnify the Releases for any cost associated with defending such a claim, including but not limited to attorney's fees. This clause is not intended to restrict Releases' right to retain the service of any attorney of their own choosing.
5. Participant (or parent or legal guardian if a minor) hereby acknowledge THE ACTIVITIES OF THE EVENTS ARE VERY DANGEROUS and involve the risk of serious injury, death or property damage. Each of the individuals SIGNING also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT OPERATION OR PROCEDURES OF THE RELEASES.
